



Wildlife Management Department Half Day Guided VARMINT Hunt & Day Fishing

Spend a half day immersed in the diverse landscape of Tejon Ranch with a dynamic hunt that combines Coyote calling and introduction to our ponds. This experience is designed for those looking to maximize time in the field while enjoying multiple opportunities the ranch has to offer.

The hunt begins with a guided varmint pursuit, focusing primarily on coyotes, along with other opportunistic species depending on season and conditions. Guests will hunt alongside experienced guides using proven calling techniques, strategic setups, and access to prime habitat across the ranch's expansive terrain.

Following the hunt, guests will transition to one of the ranch's private fishing locations. Whether casting from shore or simply unwinding by the water, the fishing portion offers a more relaxed pace and a chance to take in the natural beauty of the property.

This half-day experience is ideal for individuals or small groups seeking variety, action, and a well-rounded outdoor outing without committing to a full-day hunt.

Schedule: Hunters will check in at the Tejon Ranch Resource Management Office (4427 Lebec Rd. Lebec, CA 93243), See seasonal hunt times below. After checking in, you will view an orientation video with your guide or a ranch representative. Each hunter should have their rifle sighted in before arrival and be prepared to hunt at first light.

- **Fall hunt 5:30 am – 3:30 pm
(August 1st - January 31st)**
- **Spring hunt 6:30 am – 4:30 pm
(February 1st - July 31st)**

What to Expect:

Hunters are expected to come prepared for vast and varying terrain, changing weather conditions, moderate hiking and basic needs. The average shot distance is under 250 yards. Each hunter should bring lunch to eat in the field and an ice chest with ice for transporting harvested game when leaving the ranch. Please note, Tejon Ranch requires **non-lead ammunition** for your firearm, A valid California hunting license, and A California Fishing License.
