The North Membership Area at Tejon Ranch spans over 57,000 acres of diverse wildlands, offering members unparalleled access to one of California's most remarkable landscapes. From rolling grasslands and oak-covered hillsides to rugged canyons and expansive valleys, this area provides a truly unique setting for outdoor recreation and hunting.

The 2026 Fall North Membership season runs from September 1, 2026 through January 31, 2027, giving members five months to explore, hunt, and enjoy all that the North area has to offer.

As with all Tejon Ranch memberships, North Membership represents more than access to land — it reflects a shared commitment to ethical hunting, and the legacy of California's largest contiguous expanse of private property.

As a member, you may choose from two distinct membership options based on your interests:

- A Small Game Hunting Membership for those who want to focus on small game opportunities.
- A Small Game & Pig Hunting Membership, which combines small game hunting with the added benefit of pig hunting and additional guest access.

Members of the North Hunt Club will have the ability to rent cabins within the North Hunt Club area as well as dry camping at the campsite located at Crane Canyon. All the lodging opportunities will be subject to availability. All Cabins require a one Night Minimum Stay.

2026 Fall North Small Game Membership

The Small Game Hunting Membership provides members and their families with exclusive access to the 57,000-acre North Membership Area during the 2026 Fall season. This package is designed for those who want to focus on small game hunting while enjoying the expansive landscapes and abundant wildlife that define the South.

Details of 2026 Fall North Small Game Membership

- Season: September 1, 2026 through January 31, 2027
- \$4,465.00 Membership Package.
- Includes Ten (10) guest passes.
 - Each valid for forty-eight (48) hours
 - Additional guest passes can be purchased for \$135 each (limit 5 total per season, per membership)
 - Same guest may only accompany members 3 times in total per season.
- Small game hunting across the North Membership area
 - Varmints included
 - Per California Department of Fish and Wildlife Regulations and Seasons)
- Fishing (Catch & Release Only)
 - All individuals 16 years of age and over must have valid California fishing license
- Upland bird hunting*
 - Dove
 - California Valley Quail
 - Mountain Quail
 - **Note: Does Not Include Turkey**

HUNT AT TEJON

2026 Fall North Membership

The Fall North Membership expands upon the North Small Game Membership by adding the opportunity to hunt wild pigs across the 57,000-acre North Membership Area. This package is ideal for members seeking a more comprehensive hunting experience, combining traditional small game opportunities with the challenge of pig hunting in one of Tejon Ranch's most diverse and scenic regions.

Details of 2026 Fall North Membership:

- Season: September 1, 2026 through January 31, 2027
- \$5,565.00 Membership Package.
- Includes Fifteen (15) guest passes.
 - Each valid for forty-eight (48) hours
 - Additional guest passes can be purchased for \$135 each (limit 5 total per season, per membership)
 - Same guest may only accompany member 3 times in total whether membership is fall, Fall or year round
- Includes Five (5) pig tags
 - While we will continue to focus on harvesting boars only, one (1) sow may be taken without penalty
 - If a second sow is mistakenly taken, it will count as (2) of your remaining pig options
 - ALL harvested pigs must be verified by Tejon staff
 - Guest hunting wild pigs must use one of the members' allotted pig options

Members will have the ability to rent cabins within the North Hunt Club area as well as dry camping at the Vaquero Campground located adjacent to the Old Headquarters Entrance (Sebastian Road). All lodging opportunities will be subject to availability. All cabin lodging requires a one (1) night stay. (50% deposit required on all reservations.)

- **Cazador Cabin** (North) is located off Haul Road approximately 8 miles from the Old Headquarters Entrance. This cabin has a fully equipped kitchen, 3 bedrooms, 2 bathrooms, sleeps 12, all the basic amenities and can be rented for \$400 + tax per night.
- **Bloom House** (North) is located just inside the Old Headquarters Entrance. This house has a fully equipped kitchen, 4 bedrooms, 2 bathrooms, sleeps 14, and all the basic amenities and can be rented for \$400 + tax per night.
- **Cross & Crescent House (Lebec)** is located near the Ranch main headquarters, approximately three miles from the Lebec entrance gate and fourteen miles to the Sebastian entrance gate. This house has a fully equipped kitchen, 4 bedrooms, 3 bathrooms, sleeps 7, all the basic amenities and can be rented for \$425 + tax per night.
- **Vaquero Campground (North)** is available for RV's and trailers. This is a dry campground with no hookups. There are limited spots available and will be based on a first-come, first-serve basis. All RV's and trailers will need to be removed at the end of each stay. *Note: RV's and trailers may be kept at the Vaquero Campground for \$500.00 per season.
- **Haskell House (Lebec)** is located near the Ranch main headquarters, approximately three miles from the Lebec entrance gate and fourteen miles to the Sebastian entrance gate. This house has a fully equipped kitchen, 4 bedrooms, 3 bathrooms, sleeps 5, all the basic amenities and can be rented for \$425 + tax per night.

Details and Basic Hunt Rules include:

Small Game Membership is offered to outdoors men and women with the highest ethics. Members must comply with all California Department of Fish and Wildlife regulations, as well as Tejon Ranch access and hunting rules.

- **The possession of ammunition containing lead, whether accompanied by a firearm capable of firing such ammunition, is strictly prohibited on the Ranch.**
- All members, family members and guests (hunting or non-hunting) must always have in their possession a valid hunting and/or access permit while on Ranch property.
- All members, family members and guests must purchase liability insurance from Tejon Ranch at the rate of \$35.00 per year (September 1-July 31) prior to entering the Ranch. Each person, hunting or not, must carry the insurance. (No Exceptions)
- Tejon Ranch reserves the right to guide hunting trips on entire Ranch and the right to access and use all facilities within the area; there will also be other ranch activities, including but not limited to filming, public access events, and development planning activities that may limit access to portions of the Ranch periodically. Tejon Ranch also reserves the right to add, alter or cancel memberships at any time.
- No ATV's, motorcycles, quads or off-road vehicles are permitted on Tejon Ranch at any time. **NO EXCEPTION.** 4x4 vehicles are allowed.
- All members are expected to take great care of this special piece of Tejon Ranch. The Ranch expects members to always leave the area better than they found and communicate with Ranch management if any rules, regulations or the highest hunting ethics are not respected.
- Tejon Ranch reserves and shall have the right in its sole and absolute discretion to prohibit access to all or any portion of Ranch property due to inclement weather, fire, flooding, snow or other acts of God that management feels is a safety concern to the member and/or could be detrimental to the integrity of Ranch infrastructure until conditions have changed, and it is deemed safe for access as determined by the Ranch. In the event of such a closure, no refund or proration for days closed shall be provided.
- Each member, whether they are returning or not, will be required to watch the Tejon Ranch orientation video.
