- o While we will continue to focus on harvesting boars only, one (1) sow may be taken without penalty
- o If a second sow is mistakenly taken, it will count as (2) of your remaining pig options
- o ALL harvested pigs must be verified by Tejon staff
- o Guest hunting wild pigs must use one of the members' allotted pig options

Details and Basic Hunt Rules include:

Membership to Tejon Ranch's Hunt Club is offered to outdoorsmen with the highest ethics. Members must comply with all Tejon Ranch access and hunting rules, as well as California Department of Fish and Wildlife regulations.

- **The possession of ammunition containing lead, whether accompanied by a firearm capable of firing such ammunition, is strictly prohibited on the Ranch.**
- All members, family members and guests (hunting or non-hunting) must always have in their possession an access permit with a valid hunting license and hunting permit, if applicable, while on Ranch property.
- All members, family members and guests must purchase liability insurance from Tejon Ranch at the rate of \$35.00 per year (September 1-Aug 31) prior to entering the Ranch. Each person, hunting or not, must carry insurance. (No Exceptions)
- All pig hunting members must have valid stamped Tejon Ranch pig tags issued through the Wildlife Management Office prior to entering the Ranch. Each member or guest must complete a tag upon harvest and return to the Wildlife Management Office or leave in sign in seat upon departure.
- Tejon Ranch reserves the right to guide hunting trips on entire Hunt Club area and the right to access and use all facilities within the area; there will also be other ranch activities, including but not limited to filming, public access events, and development planning activity that may limit access to portions of the Hunt Club area periodically. Tejon Ranch reserves the right to add, alter or cancel memberships at any time.
- For the 2026-2027 season, there is no minimum age to hunt upland birds, and small game on the Ranch as long as the individual possesses a valid California hunting license with proper validations.
- No ATV's, motorcycles, quads, e-bikes or off-road vehicles are permitted on Tejon Ranch at any time. **NO EXCEPTION.**
- All members are expected to take great care of this special piece of Tejon Ranch. The Ranch expects members to always leave the area better than they found and communicate with Ranch management if any rules, regulations or the highest hunting ethics are not respected.
- Tejon Ranch reserves and shall have the right in its sole and absolute discretion to prohibit access to all or any portion of Ranch property due to inclement weather, fire, flooding, snow or other acts of God that management feels is a safety concern to the member and/or could be detrimental to the integrity of Ranch infrastructure until conditions have changed, and it is deemed safe for access as determined by the Ranch. In the event of such a closure, no refund or proration for days closed shall be provided.
- Each member, whether they are returning or not, will be required to watch the Tejon Ranch orientation video. Any violation of the terms, covenants, conditions, or rules and regulations contained in your Access Permit may result in such remedial action as Tejon Ranch deems necessary in its sole discretion, including, without limitation, immediate ejection from the Ranch, with no refund of fees already paid or waiver of fees still owing, and permanent termination of all future access privileges.
